Functional Testing:

Tet System Approved Fetal Bovine Serum has been tested at Takara Bio USA, Inc. with the CHOAA8-Luc Tet-Off® cell line which is sensitive to nanogram concentrations of tetracyclines. The full range of induction possible with the Tet system was observed.

Manufacturer Testing:

The raw fetal bovine serum used in the manufacture of this material was collected and processed from abattoirs located in Mexico. The maternal animals from which the fetal blood was derived received ante- and post- mortem inspections at the time of slaughter under the supervision of a licensed veterinarian and appeared free of infectious and contagious diseases and parasites. This material has been tested via 9CFR113.53 for Adventitious Viral Agents. The Fetal Bovine Serum (FBS) was processed in the USA. The lot was quarantined until USDA safety tested and approved this lot for commercial distribution. The cattle have never been in contact with or have never had any association to any herds that have had any breakout of BSE (Bovine Spongiform Encephalopathy). The cattle have never had any association with any other animal or animals that could transfer TSE (Transmissible Spongiform Encephalopathy).
