pAcGFP1-N1 encodes a green fluorescent protein from *Aequorea coerulescens*. pAcGFP1-N1 is designed for studies in mammalian systems. This vector allows expression of a protein of interest as an N-terminal fusion to AcGFP1. The fusion vector can also be used as a cotransfection marker since the unmodified vector will express fluorescent protein. The fluorescent protein coding sequence in this construct has been human codon-optimized for efficient expression and enhanced brightness in mammalian cells.
