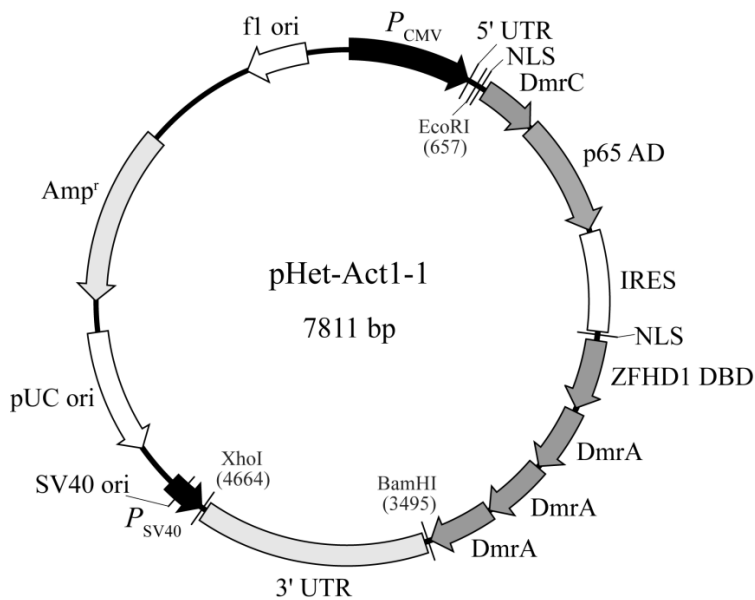


Figure 1. pHet-Act1-1 vector map.
